Your generosity has helped us secure our core mission projects: the [Omid Memorial](#), which serves as a testament to the lives snuffed out by state violence in Iran, and the [Human Rights and Democracy Library](#), a vital bilingual resource for those working to protect the dignity of all Iranians.

Your contribution will also make possible the expansion of ABC's public engagement and awareness-raising efforts, including:

- ABC's report on juvenile executions, titled [Children, Yet Convicted as Adults](#), which challenges Iran's justifications for the use of capital punishment against child offenders, examines the question of maturity through the lens of empirical scientific research, and calls on the Islamic Republic to take immediate action to ensure that no individual is put to death for crimes committed as a child.
- Our timeline project titled, [The Cost of Defending the Rule of Law](#). This timeline provides a glance at four decades of persecution of lawyers. It is the first phase of a project that attempts to provide an understanding of the root causes of the systematic persecution of human rights defenders, lawyers, journalists and others who have called for reform and exposed abusive laws and practices.
- The "[Death Penalty Page](#)" a new ABC resource that pulls from 15 years of ABC's meticulous documentation on hundreds of cases of violations of the right to life. This project brings into focus global abolitionist arguments from several perspectives including religious, academic and legal fields. Our work is making accessible a number of valuable tools for those working toward the abolition of the death penalty in Iran and worldwide;
- ABC's recent translation and publication of a study about the [Law of Talion](#) seeks to increase accessibility and promote transparency about the international norms of human rights laws and practices. It is also generating significant interest on Iranian social media networks despite its explicit challenge to official narratives about the origins and religious necessity of the law.

This year, ABC continues to do the important work of advocating for human rights and democracy in Iran, a mission that would not be possible without your support.
